BEFORE/AFTER SCHOOL PARENTAL AGREEMENT

- 1. After School will be provided for TK-5th grades and will be held at Harris campus. School teachers will escort students to the After School classrooms to check them in to the program.
- 2. Study Hall is provided for students in grades 6th-12th at Harris Campus. Payment for services will be paid using FACTS with all other school related charges.
- 3. Before School service will be located in the FLC at Harris Campus from 7:00 AM until 7:20 AM.
- 4. Adventure Days will be provided for students TK-5th grade and will be held at Harris Campus, at the rate of \$40 per student, per day; unless your student is signed-up for Before/After School PLUS Adventure Days program. All Adventure Days will have a sign-up sheet at the check-out desk or email briannabamberg@ hgchristian.org; all students planning to attend need to be signed-up in advance. Students may not be added to the list once the cut-off date has passed. If your student is a "no-show" the day of the event(s), you will be charged \$20 per day, per student.
- 5. A late fee of \$1.00 per minute (after 6:00 PM) will be added to your account whenever you are late picking your child up from After School and/or Adventure Days.
- 6. My child has permission to attend any field trips that may be planned during After School or Adventure Days. I understand that my child may be photographed while participating in After School or Adventure Day activities.
- 7. The church or school will not be held liable for any accidents or injuries during Before/After School, Adventure Days or Study Hall activities.
